



HSBC x Samsung Website Exclusive Promo Terms & Conditions

1. For avoidance of doubt, an HSBC credit card is in good credit standing if there is no reason for HSBC to restrain, suspend, cancel, withdraw or terminate the card pursuant to the HSBC Card Terms and Conditions as well as Legal and Compliance Policy considerations.

Accepted cards are as follows: HSBC Visa Classic, HSBC Mastercard Classic, HSBC Red Mastercard, HSBC Gold Visa Cash Back, HSBC Gold Mastercard, HSBC Advance Visa, HSBC Premier Mastercard, HSBC Platinum Visa Rebate, HSBC Live+, and HSBC Premier Travel Card. Debit and Corporate cards are excluded from the Promo.
3. Promo shall run from March 31, 2026 to December 31, 2026 ("Promo Period"). All transactions must be made within Promo Period to avail of the Promo.
4. Cardholders must settle payment with their HSBC Credit Card to enjoy the Offer.
5. Qualified Cardholders can enjoy discounts on participating devices/products with free delivery, additional Php1,000 discount for first time purchase, and trade-in for some products, subject to terms and conditions, using their exclusive access code.
6. A Cardholder is entitled to one unique access code only.
7. Prices of Samsung products on the exclusive Samsung website for HSBC Cardholders are discounted up to 40% off from Suggested Retail Price (SRP).

9. The Promo is open to all principal and supplementary HSBC credit and debit cardholders whose cards have been issued by HSBC and have available credit limit.

11. Only one (1) qualified HSBC Card may be used per single-receipt transaction, and only one (1) qualified card may be accepted per Cardholder. Splitting of transaction is not allowed.

14. Total Spend Limit per Cardholder is 412,500 Philippine Pesos and a maximum of 3 items per product category per calendar year.

16. The Offer cannot be used in conjunction with any other discounts, promotions and disco items, unless specified.
17. The Offer is non-transferable.
